Types of Data collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Camera permission; Microphone permission; Storage permission; Biometric Data access permission; Usage Data; Data communicated while using the service; device information.

Complete details on each type of Personal Data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the Data collection.

Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using this Application.

Unless specified otherwise, all Data requested by this Application is mandatory and failure to provide this Data may make it impossible for this Application to provide its services. In cases where this Application specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service.

Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner. Methods of processing

In addition to the Owner, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of this Application (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications

agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Owner at any time.

Legal basis of processing

The Owner may process Personal Data relating to Users if one of the following applies:

- Users have given their consent for one or more specific purposes. Note: Under some
 legislations the Owner may be allowed to process Personal Data until the User objects to
 such processing ("opt-out"), without having to rely on consent or any other of the following
 legal bases. This, however, does not apply, whenever the processing of Personal Data is

Place

The Data is processed at the Owner's operating offices and in any other places where the parties involved in the processing are located.
